FORM 03 – ARTICLES OF AMENDMENT

Please complete all sections. If completing the form by hand, ensure all hand-printed text remains within the provided fields. Otherwise, the application may be considered unacceptable for registration.

Section 1
Provide the full legal name of the corporation registering its articles of amendment.
Section 2
Set out the changes to the Articles. Numbering and wording must match the Articles on file with the Registry. In the event of any discrepancy, the Articles on file with the Registry are the governing document. • Change to the Articles must be made in accordance with sections 29 and 179 of the <i>Business Corporations Act</i>. • Each amendment must clearly reference the specific provision of the Articles being amended (e.g., item, section, subsection, paragraph, clause) and use the exact wording. • If the amendment changes the corporation's name, the new name must comply with section 10 and 12 of the <i>Business Corporations Act</i> and the corporate name provisions of the <i>Business Corporations Regulations</i>. • If the amendment changes the corporation to a numbered company, leave a blank space to the left of the new name and type or neatly hand write "Northwest Territories" or "N.W.T." followed by a legal element such as Inc., Ltd., Corp. etc. (e.g. _____ N.W.T. Ltd.). • If the amendment changes the NWT municipality listed in the Articles, only the municipality within the Northwest Territories should be provided. Do not include a full address.
Authorized Signature and Date
Include the full name of the authorized submitter, the submitter's signature, and the date of signing. Using the dropdown menu, select the submitter's title. The signature must not be a copy, stamp, or electronic signature.
